

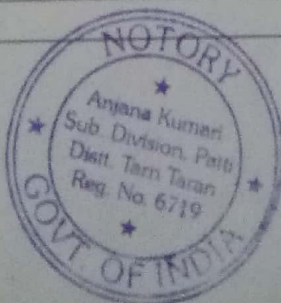


AFFIDAVIT

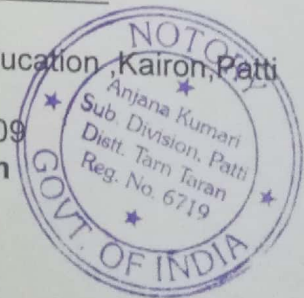
